## 7/ Planning matters;

- Green lane; it is understood that the scrap yard is subject to an Enforcement order. Clerk to monitor progress.
- Crown Public House- the extractor fan for the kitchen, covered by planning application 11/15966/FUL, has been redesigned. However a further visit by Environmental Health Officers has confirmed that the noise level is still too high and they are dealing.
- Grammar School; application 11/16217/FUL for the provision of portakabin modular classrooms was
  discussed. The meeting decided to object on the grounds that additional pupils would generate an increase

#### 11/ Roads, Highways& Footpaths;

- Community gang; the next visit is due on  $6^{th}$  December.
- Footpath- Green Lane; Clerk is still awaiting a reply from Paul Rochfort of the County Council regarding the ditches being filled with rubble and used for parking vehicles. Concern was also raised about a large excavation in a field adjacent to the lane.
- Footpath Survey; has been completed and will be collated and presented to the January meeting for discussion.
- Road salt; a quantity has been deposited at intervals on Barn Bank Lane. Highways to be approached for a similar supply on Hyde Lea bank.
- Dog Fouling; request for litter bins at the bottom of Bradley Lane and Orchard lane. Clerk to liaise with Streetscene regarding provision and location.
- Crown pub; complaints that is looking shabby and needs a coat of paint. Clerk to contact Enterprise Inns.
- Tree branches; complaints that some branches are overhanging the road and could present a possible hazard will be referred to Highways.
