HYDE LEA PARISH COUNCIL

Minutes of the Parish Council meeting held on Wednesday 9th March 2016 at Hyde Lea & Coppenhall village hall.

- 01: The chairman welcomed those present and the meeting started at 19.30hrs.
- 02: Apologies; had been received from, Borough Councillors Mr S Leighton & Mr R Sutherland.

03; Matters raised by members of the public;

Mr Lloyd-Davies referred to correspondence he had had with Jeremy Lefroy our local MP regarding the UK membership of the European Union. It was confirmed that nothing has been heard from either the Borough or County Councils on this subject.

04: Minutes of the Parish Council meeting held on 13th January 2016;

The minutes, having been previously circulated, were approved and signed as a true record.

05: Report on matters arising from the meeting not covered elsewhere on the agenda;

2 Ridgeway Close; concerns had been raised about building work on an adjoining property. A visit by a planning officer had confirmed that the work complies with legal requirements.

Bring sites; this refers to the skips on the car park of the Crown. The Borough Council contacted the parish before Christmas to advise that these will be withdrawn as a cost saving exercise. The clerk understands that nothing has yet been decided but consultation will be made with the 2 ward Borough Councillors and a questionnaire will be sent to residents.

Broad band; an email was received which was circulated regarding broadband provision. Residents have to apply to their service provider and pay the additional cost, it is not automatically provided.

Stoneleigh Court/Harptree; it appears that there is a dispute over the boundary between the two parties. As the parish council cannot get involved in such disputes it was suggested that the respective residents consult the deeds to their properties which should clarify matters.

Auto-pensions enrolment; clerk explained that he had been in correspondence with both the Pensions Administrator and Autela [our payroll provider] about the implications of this legislation. He is not personally liable for enrolment due to age and earnings limit, but the parish council has to be registered. This was dealt with towards the end of 2015 but following a phone call received by Councillor Edwards it appears that the documents went astray in the post. These have since been redone and posted.

A commemorative medal has been issued in respect of the Queens 90th birthday and a sample enclosed for the councillor's consideration. It was considered more suitable for schools and of no interest to the council.

09; Village hall matters;

Nothing to report from the last meeting. However it is noted that there is a new booking secretary.

10: Roads, Highways& Footpaths;

Footpath No 5; Councillor Edwards reported that it appear that some residents have moved the boundaries of their gardens and have encroached onto the footpath. The clerk had been made aware of this and had reported matters to the Rights of Way Officer for investigation.

Hyde Lea bank; the gulley is still overflowing and needs investigation as to whether it is blocked. Clerk to liaise with Highways.

Community paths initiative; it was agreed that a grant be requested to replace the style on Green Lane onto Footpath 13 with kissing gate.
