Village gateway signs; research had been done into providing gateway signs at the entrance to the village at the bottom of Hyde Lea bank.

Community speed watch; has been underway and currently there are 5 volunteers in training. To date they have detected over 70 vehicles exceeding the speed limit, 2 or 3 are repeat offenders

Bradley lane -grass cutting; concern has been raised by some residents about an area of uncut grass. The ownership of the land is in question but the Land Registry have been contacted to confirm ownership.
