Prior to the meeting proper a lengthy discussion took place about the Crown public house and the fact the Mr Beedles the regional manager of Stonegate had not attended the meeting. Various points were raised and eventually it was decided that the residents would form a committee to take the matter forward directly with Stonegate.

O1: The chairman welcomed those present and the meeting started at 7.30pm. No apologies received.

- 03; No interests declared, or dispensations requested by councillors on any agenda items.
- 04: Minutes of the Parish Council meeting held on 9th November 2022;

The minutes, having been previously circulated, were approved and signed as a true record.

05: Report on matters arising from the meeting not covered elsewhere on the agenda;

Defibrillator; Councillor Edwards reported that the original machine was still with WEL Medical awaiting software update. We have been supplied with a replacement model which is in situ. He is also trying to organise a training session dependant on locating a trainer.

06; Councillor Sutherland;

Gave details of a contact for the council to get in touch with and invite to our next meeting to discuss Speedwatch.

He has recently met with Mr James Green, the new Fire Commander based at Beaconside.

07; Councillor Winnington;

Reported that the current County Council contract with Amey was shortly finishing. He was also asked about the trees on Hyde Bea bank and the lack of County Council action. He suggested we contact Highways via him for an update.
