Green lane parking; Councillor Eaves reported that a vehicle had been parked at the entrance to the lane causing an obstruction. This has now been removed.

Defibrator pads; Councillor Edwards reported that the defibrillator has now been registered on the national register [The Circuit] . The pads need replacing in January 2020. It was also suggested that further training be organised .
